WORKCOVER PREMIUMS ORDER (NO. 31) 2023/2024

Specific Values and Rates Determined by the Authority Itself

Notice is hereby given that in accordance with the WorkCover Premiums Order (No. 31) 2023/2024 (*the Premiums Order*), the Victorian WorkCover Authority itself has determined the following values and rates for the purposes of the Premiums Order, for and in respect of the 2023/2024 premium period.

Specific Values and Rates

1. For the purposes of subclause 5(2) of the Premiums Order, the *minimum premium* is \$330.
2. For the purposes of subclause 10(2) of the Premiums Order, the *buy-out value* is 0.1.
3. For the purposes of clause 11 of the Premiums Order, the *deductible amount* is 15,500.
4. For the purposes of subclause 12(2) of the Premiums Order, the *sizing value* is 1,700,000.
5. For the purposes of subclause 14(2) of the Premiums Order, the *minimum capping factor*:
 - a) for an employer that is a *small employer* within the meaning of subclause 12(5), is 0;
 - b) for an employer that is a *public sector employer* within the meaning of subclause 5(2) but not a *small employer* within the meaning of subclause 12(5), is 0; and
 - c) for any other employer, is 0.
6. For the purposes of subclause 14(2) of the Premiums Order, the *capping value*:
 - a) for an employer that is a *small employer* within the meaning of subclause 12(5), is 1.75;
 - b) for an employer that is a *public sector employer* within the meaning of subclause 5(2) but not a *small employer* within the meaning of subclause 12(5), is 1.75; and
 - c) for any other employer, is 1.75.

Industry Rates and Industry Claims Cost Rates

7. For the purposes of subclause 29(1) of the Premiums Order, the *industry rate* and the *industry claims cost rate* for each WorkCover Industry Classification listed in Schedule 1 of the Premiums Order shall be the percentage amounts specified in the table commencing on the following page.
8. For the purposes of subclause 29(6) of the Premiums Order, the *default industry rate* is 18.000% and the *default industry claims cost rate* is 0.177%.
