WORKCOVER PREMIUMS ORDER (NO. 32) 2024/2025

Specific Values and Rates Determined by the Authority Itself

Notice is hereby given that in accordance with the WorkCover Premiums Order (No. 32) 2024/2025 (*the Premiums Order*), the Victorian WorkCover Authority itself has determined the following values and rates for the purposes of the Premiums Order, for and in respect of the 2024/2025 premium period.

Specific Values and Rates

- 1. For the purposes of subclause 5(2) of the Premiums Order, the *minimum premium* is \$360.
- 2. For the purposes of subclause 10(2) of the Premiums Order, the *buy-out value* is 0.1.
- 3. For the purposes of clause 11 of the Premiums Order, the *deductible amount* is 15,500.
- 4. For the purposes of subclause 12(2) of the Premiums Order, the *sizing value* is 2,000,000.
- 5. For the purposes of subclause 14(2) of the Premiums Order, the *minimum capping factor*:
 - a) for an employer that is a *small employer* within the meaning of subclause 12(5), is 0.25;
 - b) for an employer that is a *public sector employer* within the meaning of subclause 5(2) but not a *small employer* within the meaning of subclause 12(5), is 0.25; and
 - c) for any other employer, is 0.25.
- 6. For the purposes of subclause 14(2) of the Premiums Order, the *capping value*:
 - a) for an employer that is a *small employer* within the meaning of subclause 12(5), is 1.3;
 - b) for an employer that is a *public sector employer* within the meaning of subclause 5(2) but not a *small employer* within the meaning of subclause 12(5), is 1.3, and;
 - c) for any other employer, is 1.3.

Industry Rates and Industry Claims Cost Rates

- 7. For the purposes of subclause 29(1) of the Premiums Order, the *industry rate* and the *industry claims cost rate* for each WorkCover Industry Classification listed in Schedule 1 of the Premiums Order shall be the percentage amounts specified in the table commencing on the following page.
- 8. For the purposes of subclause 29(6) of the Premiums Order, the *default industry rate* is 18.000% and the *default industry claims cost rate* is 0.163%.
